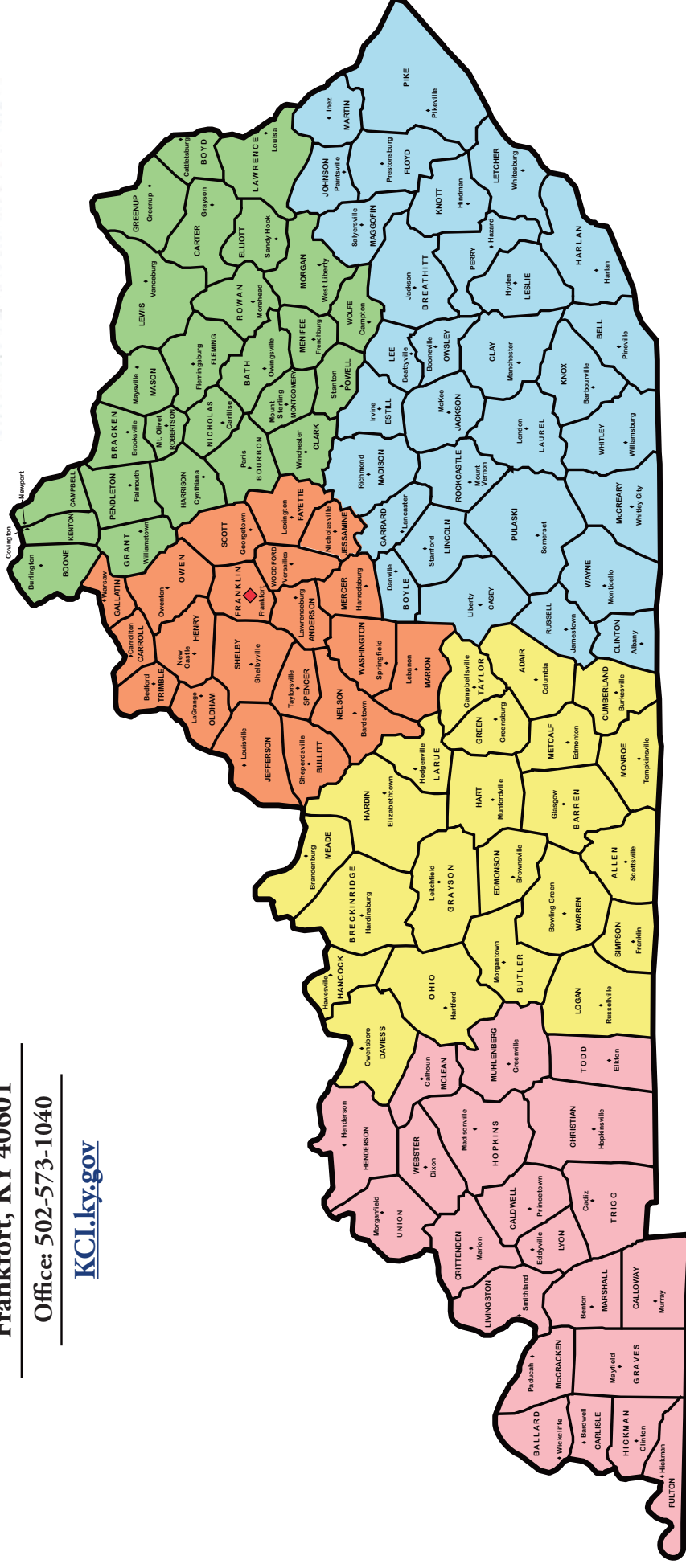

KCI's Mission Statement

To provide inmates with a realistic work experience and teach marketable job skills. This is part of an effort to improve their chances of securing gainful employment upon release from custody, reduce the state's recidivism rate and lower the Commonwealth's resource commitment for maintaining the prison system.

Kentucky Correctional Industries (KCI) was founded in 1954 with a mandate to provide training and employment to state inmates. Today, KCI employs over 700+ state inmates. By giving inmates the opportunity to learn marketable skills and develop good work habits, KCI has contributed to the reduction of recidivism, improved prison safety, and lowered the cost of incarceration throughout the state prison system.

KCI receives no appropriated tax monies and generates all operating funds and expansion capital from industry profits. KCI incurs the normal operating expenses any private company would incur such as utilities, salaries and equipment.

The success of KCI is not only measured in dollars, but in the reduction of the recidivism rate for those inmates trained in our programs. An independent study done by Eastern Kentucky University, College of Criminal Justice, found only 13.5% of inmates who had worked in KCI industries returned to prison, compared to 42% returning from the general population.

KCI is now structured into 16 separate industries each headed by an Operations Manager able to quickly make the appropriate business decisions necessary to meet your evolving procurement needs. In these times of heightened budgetary constraints, we recognize the importance of making wise purchases of products and services. That is why we have formed several important partnerships with nationally recognized suppliers, who work with prison industries throughout the United States. We think you will agree they have enabled us to offer a great selection of competitively priced products and services.

Disclaimer

Due to the uniqueness of working with inmate labor within an institutional environment, deadlines or production may be compromised or altered. KCI will make every effort to communicate this to our customers should those instances arise.

Delivery

Due to departmental policies and regulations, KCI is prohibited from delivering to private residences.

Catalog pricing reflects customer pick-up at the Frankfort warehouse loading dock only.

Catalog pricing for items produced at the Garment Plant and the Soap Plant include shipping by a third party entity.

Items delivered by one of KCI's fleet of trucks will have a delivery charge added to the customer invoice. This is based on the number of miles from KCI's Frankfort warehouse to the customer's destination, number of trips and trucks needed for delivery.

Contact your sales representative for current pricing.

Inside delivery and/or set-up is available upon customer request. See your sales representative to discuss the charge. Charges will be added to the customer's invoice.

Please provide the following information when requesting inside delivery and set-up of furniture orders:

- Floor location in the building
- Availability of freight elevator
- Size of elevator
- Are stairs the only access to floor location?
- Width of stairs
- Width of narrow hallways and doors
- Any unusual circumstances regarding the location

Providing this information prior to delivery will encourage efficient scheduling of equipment and personnel to ensure reasonable charges are added

to your invoice. Occasional delivery delays may be experienced due to scheduling considerations on all inside delivery and set-up orders.

KCI trucks are scheduled to service areas in Kentucky on a timely basis. Delivery of the order will be made when the KCI truck is scheduled into the customer's area in Kentucky.

Ordering

Please note the contact person and phone number on all Purchase Orders. Billing and shipping address must be shown on the order. To avoid misunderstandings, the catalog number, as well as the item description must be used. Where color or finish is listed, please designate preference on the order. Do not send check or remittance with the order. Telephone orders are accepted; however, these should be followed by a written order marked "CONFIRMING" to avoid duplication.

Receiving

When merchandise is received, if shipping damage or other defects are noted, please do not accept the merchandise. Please make a notation of the problem on both copies (yours and the driver's) of the delivery form. HAVE THE DRIVER SIGN BOTH COPIES. If a concealed shortage, overage, or damage is discovered later, notify KCI within 15 working days.

Warranty

KCI warrants 12 months (1 yr) with proof of purchase on all wood, metal & seating items to be free from defects in materials and/or workmanship. If any defect is discovered within the 1-year warranty period, KCI will repair or replace (at KCI discretion) the unit free of charge. All service requests must be in writing and directed to the attention of your Sales Representative.

Adirondack Series furniture is warrantied for 90 days to be free from defects in materials and/or workmanship. If any defect is discovered within the 90-day period, KCI will repair or replace (at KCI discretion) the unit free of charge. All service

requests must be in writing and directed to the attention of your Sales Representative.

These warranties do not apply to defects caused by abuse, misuse, neglect or alteration of the unit.

Service Calls

If after the 1-year warranty period (90 days for Adirondack Series furniture) your unit requires service, repair or replacement, a service call will need to be requested in writing to your Sales Representative.

Office Seating service calls will be \$85 for KCI to pick-up the unit and send to the plant for repair. This fee does not include the cost of parts, fabric and labor for plant repair. Those charges will be quoted by the plant prior to repair.

Furniture service calls will be \$125 for KCI to repair on site or pick-up the unit to be sent to the plant for repair. This fee does not include the cost of parts and labor for plant repair. Those charges will be quoted by the plant prior to repair.

ABOUT KCI

KENTUCKY CORRECTIONAL INDUSTRIES was founded in 1954 with a mandate to provide training and employment to state inmates. Today, *KCI* employs over 900 state inmates. By giving inmates the opportunity to learn marketable skills and develop good work habits, *KCI* has contributed to the reduction of recidivism, improved prison safety, and lowered the cost of incarceration throughout the state prison system. *KCI* receives no appropriated tax monies and generates all operating funds and expansion capital from industries' profits. *KCI* incurs all of the normal operating expenses any private company would incur, such as utilities, salaries and equipment.

The success of *KCI* is not only measured in dollars, but also in reduction of the recidivism rate for those inmates trained in our programs. An independent study done by Eastern Kentucky University, College of Criminal Justice, found only 13.5% of inmates who had worked in *KCI* Industries returned to prison, compared to 42% returning from the general population.

THIS HANDY GUIDE ANSWERS QUESTIONS THAT MANY CUSTOMERS HAVE CONCERNING KCI FURNITURE REUPHOLSTERY AND REFURBISHING SERVICES

Whether it's that worn favorite chair or a family heirloom, the KCI furniture refurbishing and upholstering plants can put a spark of life back into any piece of furniture.

KCI's upholstery and refurbishing plant takes great pride in providing quality service to organizations such as state agencies, local government, non-profit organizations, hospitals, private sector and residential. Kentucky regulations prohibit Kentucky Correctional Industries to provide goods and services outside the state of Kentucky.

While pick-up service is available to state agencies and private businesses, individual orders must be brought to the KCI Central warehouse (Frankfort). Your furniture will be sent to the plant for a cost estimate.

We also offer a large variety of fabric, wood, and stain selections, such as cherry, mahogany, maple, walnut, oak, ash and more. To view your array of options, please visit our central office showroom. Residential customers are required to provide their own fabric.

We also refurbish metal items such as file cabinets and outdoor furniture. Refurbishing metal is completed through a process, which starts with oven-baking the metal to strip off the old paint, and then the metal is dipped in a chemical bath for corrosion resistant paint adhesion. From there your item is powder coated and baked with your selected paint color, which will have your metal item looking like new again.

Q: What exactly does KCI reupholster and refinish?

A: KCI reupholsters and refinishes many items such as sofas, chairs and wood furniture.

Q: What is the procedure to have my item reupholstered?

A: Bring your item to KCI Central Showroom/Warehouse on Highway 421/Leestown Road in Frankfort. A salesperson fills out proper paperwork. We will then send the furniture to our plant for quoting. In the field, contact your Sales Representative (identify your sales rep by using the map on the inside front cover).

Q: When is the best time to bring in my furniture?

A: 8 a.m. - 3 p.m., Monday through Friday.

Q: Can you give me an estimate of how much it will cost to reupholster my item at your showroom?

A: Your furniture will be estimated at our plant. We do not estimate furniture at our showroom.

Q: How many yards of fabric will I need?

A: You will be informed once the plant has completed your furniture estimate. At that time you will be informed of the amount of fabric needed to reupholster your furniture. KCI also has an estimate chart. This is not exact, but is a good guide to better gauge approximate yardage of fabric needed.

FREQUENTLY ASKED QUESTIONS

Q: *Are there extra costs associated with reupholstering furniture?*

A: There can be if your item needs extra work. Other costs may include, but are not limited to cushions, springs, gimping, tufting and wood refinishing.

Q: *How long does it take to get an estimate?*

A: KCI usually sends a truck to the plant once a week. You can expect estimates within 2 weeks. You then have 2 weeks to either accept or decline the estimate. Due to the high demand of this service, items will be returned to the KCI Warehouse that have been quoted and have exceeded this 2 week decision time frame. Transportation charges may apply.

Q: *Once I receive my estimate, how do I pay?*

A: The most efficient way is to phone KCI Accounts Receivable at 502-782-9570 with a payment from any major credit card. You may also pay with a check or money order made payable to:

Q: *Once an estimate is completed, who will contact me?*

A: KCI staff will email or phone you with an estimate. (Payment from private individuals is due when estimate is completed, and before work can begin). A down payment may be requested.

Q: *Can I take my furniture and/or upholstery to the plant to speed up the process?*

A: Due to security reasons, we can't accept furniture or upholstery from outside sources (i.e. individuals, businesses, state employees) at our plants. Only KCI may deliver/pick-up your furniture at our plants.

Q: *Does KCI pick-up and deliver?*

A: KCI will both pick-up and deliver to state agencies and businesses. KCI can't pick-up or deliver at personal residences.

Q: *What is the total time involved to have my furniture reupholstered?*

A: It varies widely depending on the work load at the time, but on average 10 to 12 weeks.

Q: *How will I know when my furniture is ready for pick-up?*

A: Our warehouse staff will call you when your furniture has arrived and is ready for pick-up.

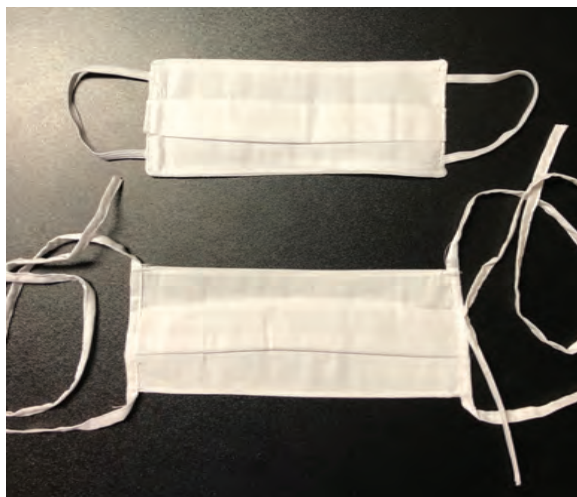

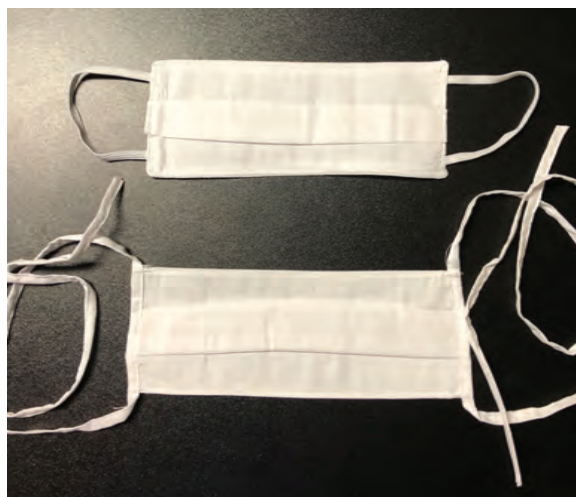

What is PIECP?

- Also known as “PIE” the program operates under statutory authority of the U.S. Congress (18.U.S.C. § 1761 ©).
- Kentucky Correctional Industries is PIECP-certified which exempts it from the normal restrictions on the sale of inmate-made goods in interstate commerce.
- Program parameters are detailed within Kentucky Revised Statute 197.105.

Why Participate?

- The program provides a stable, readily available American workforce in low cost facilities to more competitively produce your products or provide your services.
- Through inmate pay deductions administrative orders for the support of dependents are fulfilled, crime victims are compensated and inmates’ families are supported.
- Inmates gain marketable skills in a realistic work setting which improves their prospects for employment upon release and a successful transition to contributing, tax paying members of society.

GETTING STARTED...THE REQUIREMENTS

- Inmates will be paid (subject to allowable deductions) the prevailing wage for similar work performed in the locality and benefits comparable to private sector employees (overtime, workers compensation, etc.)
- Your company must certify in writing that the work performed
 - (1) will not displace employed private sector workers;
 - (2) will not be used in skills/trades where a surplus of available gainful labor in the locality; and
 - (3) will not significantly impair existing contracts.
- Prior to start-up KCI must notify organized labor and local private industry, comply with NEPA requirements and obtain written assurances from inmates that their participation is voluntary.
- The Bureau of Justice Assistance (BJA) grants approval for the project once a review of all documentation has been completed.

CURRENT WORK MANAGEMENT STRUCTURE

- **Employer Model:** The private sector partner owns and operates the project (hires, fires, trains, supervises and pays the inmate workforce). KCI assumes no major role in industry operations and exercises limited control over inmate labor performance.

PIECP FREQUENTLY ASKED QUESTIONS

Q: How is a fair inmate wage determined?

A: Demonstration that inmate workers are being paid in at least the 10th percentile of prevailing wages for similar work in that locale is generally required. Inmates cannot be paid below the standard federal minimum wage.

Q: Are inmates entitled to “employee benefits”?

A: Participation in the program is not to constitute an employee/employer relationship with the private sector partner leasing the inmate’s labor. Federal, State, and Local taxes, along with Social Security is deducted from the inmate’s pay, and worker’s compensation insurance is provided by the private sector partner, however no other “benefits” such as health or life insurance must be provided.

Q: Can our company personnel tour prospective sites?

A: Yes. KCI Personnel will arrange and accompany your designated representatives on a tour of any prospective facility.

Q: What about security of our staff working in a prison setting?

A: All state adult correctional facilities employ staff members from many different disciplines who work there every day. Staff who work in these facilities have a responsibility to follow security policies and procedures, which are in place to ensure their safety as well as the safety of the inmate population. Uniformed security staff, however, are employed in these facilities and are directly responsible for maintaining security and order.

Q: Can we utilize tools and chemicals necessary to complete our work?

A: Yes. All of our facilities have very detailed safety plans as well as tool and caustic control policies and procedures.

Q: Can we have deliveries, which would be made to a plant within a correctional facility?

A: Yes. All of our facilities have secure checkpoints/sally ports where deliveries can be made as needed, either by vehicle or on foot.

Q: Can we use tools and chemicals that are owned by the Department of Corrections (DOC) or KCI?

A: No. In the Employer model, the private sector partner would provide all necessary tools, etc.

Q: What about insurance?

A: KCI/DOC maintains insurance on all state owned property and equipment. The private sector partner would need to provide and maintain insurance on parts, tools, machinery, etc. that it owns and which is being used in a PIE operation. As well as providing workman’s comp for inmates.

Q: What about shift work?

A: The inmate labor force would generally be available for standard day shift work Monday-Friday; however, in the event that occasional overtime is necessary, it may be approved by the DOC/KCI on an “as needed” basis.

Q: Can we alter, or renovate existing facilities that are owned by the DOC/KCI to meet our needs?

A: Yes. With the prior approval of the DOC/KCI.

Q: Can we hire inmates after they serve out or leave prison on parole?

A: Yes. The purpose behind PIE is to not only provide private sector partners with a skilled workforce, but to assist inmates by providing them with marketable skills and training which will make them viable candidates for careers after incarceration.

197.105 Prison Industry Enhancement Certification Program (PIECP) -- Lease of labor of state prisoners within department's facilities for production of nonagricultural goods for sale to public and private buyers.

- (1) The department may administer a Prison Industry Enhancement Certification Program (PIECP) and may lease the labor of state prisoners within the boundaries of the state's Department of Corrections facilities for the production of nonagricultural goods for sale to both public and private buyers, if the department meets the conditions set out in this section. This section shall apply only to the leasing of labor in accordance with a PIECP and not to programs otherwise operated by Kentucky Correctional Industries.
- (2) The department shall not lease the labor of a prisoner who does not consent in writing to the leasing of that prisoner's labor.
- (3) The department shall retain full responsibility for the care, custody, and control of the prisoner and shall supply appropriate security and custody services without cost to the person leasing the labor.
- (4) The department shall ensure that the prisoner is paid wages at a rate not less than that paid for work of a similar nature in the locality in which the work takes place, as determined by the Labor Cabinet, and never less than the federal minimum wage. The final decision on the appropriate wage, in keeping with federal and state labor and wage laws, shall be made by the Labor Cabinet.
- (5) The department shall not allow a prisoner whose labor has been leased under this section to:
 - (a) Engage in work that would result in the displacement of employed workers in the specific Department of Corrections locale. As used in this paragraph, a displaced employed worker is:
 1. A civilian worker employed in the same task by the employer leasing or applying to lease prisoner labor, who would lose his or her job if the prisoner labor were leased; or
 2. A civilian worker who is employed full-time and, as a result of the prisoner labor lease, is forced to work part-time, regardless of wage increase.

A civilian worker is not considered displaced for the purposes of this paragraph if the civilian worker remains employed in a job acceptable to that worker and at equal or higher wages than that worker previously received. The employer shall provide whatever retraining is required of the civilian worker at no cost to the civilian worker;
 - (b) Labor in a skill, craft, or trade in which there is a surplus of labor for that skill, craft, or trade in that specific Department of Corrections locale;
 - (c) Perform any work that would impair existing contracts for goods or services;
 - (d) Perform leased work outside of Department of Corrections facilities; or
 - (e) Perform leased construction work inside or outside Department of Corrections facilities.

- (6) Before the commencement of any leased labor project at a Department of Corrections facility under this section, the department shall:
- (a) Receive a written projection from the Labor Cabinet that the leased labor project shall not result in acts prohibited by subsection (5)(a) to (c) of this section;
 - (b) Receive written documentation from the employer leasing or applying to lease prisoner labor agreeing to not displace any of its nonprisoner employees with leased prisoner labor;
 - (c) Have written documentation of consultation with local unions representing labor in the specific Department of Corrections facility's locale in any skill, craft, or trade in which a prisoner may labor at that facility. If a local union is not available, the department shall consult with a similar statewide union. The department shall present this information to the Kentucky State Corrections Commission;
 - (d) Have written documentation of consultation with local private businesses that may be economically impacted by the leased labor project. The department shall present this information to the Kentucky State Corrections Commission; and
 - (e) Have written documentation of compliance with the National Environmental Policy Act (NEPA).
- (7) The leasing of prisoner labor shall not be deemed to create an employer-employee relationship between the person leasing the labor of the prisoner and the prisoner. However, the person leasing the labor of the prisoner shall provide for workers' compensation coverage for the prisoner and, if applicable, Social Security coverage for the prisoner.
- (8) A prisoner, as a condition of participation in a program operating under the provisions of this section, shall agree to the deductions from the prisoner's earnings set out in this subsection. The department or the person leasing the labor of the prisoner shall deduct, in the following order, from a prisoner's gross wages:
- (a) If the prisoner is the subject of a court or administrative order for the support of a dependent, no less than twenty-five percent (25%) for the payment of the court or administratively ordered support. These deducted wages shall be paid to the Cabinet for Health and Family Services' Child Support Enforcement Program for disbursement in accordance with federal and state law;
 - (b) Twenty percent (20%) to be paid to the crime victim's compensation fund established in KRS 49.480;
 - (c) Applicable federal, state, and local taxes, including Social Security if applicable; and
 - (d) Reasonable room and board fees established by the department by administrative regulation.
- Total deductions from a prisoner's gross wages shall not exceed eighty percent (80%).
- (9) The department shall require any person leasing the labor of a prisoner to post bond,

with good surety, in an amount determined by the department, against any judgment that may be entered against the department arising from the leasing of prisoner labor to that person.

- (10) In leasing prisoner labor under this section, the department shall seek to have the labor leased to the highest responsible bidder.
- (11) The department shall provide for reasonable access to the grounds of the Department of Corrections facilities for the person leasing the inmate labor and for the location of the work and the transporting and siting of equipment and supplies, with the security of the public being paramount.
- (12) The department may promulgate administrative regulations to implement the provisions of this section.

49.480 Crime victims' compensation fund.

- (1) There is established in the State Treasury the crime victims' compensation fund, hereinafter referred to as the "fund," to be administered by the Crime Victims Compensation Board. Nothing herein shall be construed to limit the power of the court to order additional forms of restitution, including public or charitable work or reparation to the victim, to the fund, or otherwise as authorized by law.
- (2) The fund shall consist of moneys from the following: appropriations by the General Assembly; the federal government; disbursements provided under KRS 42.320(2)(g); and any other public or private source. Any unexpended balance remaining in the fund at the end of the biennium shall not lapse and be transferred to the general fund, but shall remain in the crime victims' compensation fund. Any funds not utilized by the board shall be used to provide assistance to programs for victims, and the board shall allocate such funds to any agency providing services to victims. In the event there are insufficient funds in the fund to pay all claims in full, all claims shall be paid at seventy percent (70%). If there are no moneys in the fund, then no claim shall be paid until moneys have again accumulated. In addition to payment of claims, moneys in the fund shall be used to pay all the necessary and proper expenses of the board.

CHAPTER 85—PRISON-MADE GOODS

§ 1761. Transportation or importation

(a) Whoever knowingly transports in interstate commerce or from any foreign country into the United States any goods, wares, or merchandise manufactured, produced, or mined, wholly or in part by convicts or prisoners, except convicts or prisoners on parole, supervised release, or probation, or in any penal or reformatory institution, shall be fined under this title or imprisoned not more than two years, or both.

(b) This chapter shall not apply to agricultural commodities or parts for the repair of farm machinery, nor to commodities manufac-

tured in a Federal, District of Columbia, or State institution for use by the Federal Government, or by the District of Columbia, or by any State or Political subdivision of a State or not-for-profit organizations.

(c) In addition to the exceptions set forth in subsection (b) of this section, this chapter shall not apply to goods, wares, or merchandise manufactured, produced, or mined by convicts or prisoners who—

(1) are participating in—one of not more than 50 prison work pilot projects designated by the Director of the Bureau of Justice Assistance;

(2) have, in connection with such work, received wages at a rate which is not less than that paid for work of a similar nature in the locality in which the work was performed, except that such wages may be subject to deductions which shall not, in the aggregate, exceed 80 per centum of gross wages, and shall be limited as follows:

(A) taxes (Federal, State, local);

(B) reasonable charges for room and board, as determined by regulations issued by the chief State correctional officer, in the case of a State prisoner;

(C) allocations for support of family pursuant to State statute, court order, or agreement by the offender;

(D) contributions to any fund established by law to compensate the victims of crime of not more than 20 per centum but not less than 5 per centum of gross wages;

(3) have not solely by their status as offenders, been deprived of the right to participate in benefits made available by the Federal or State Government to other individuals on the basis of their employment, such as workmen's compensation. However, such convicts or prisoners shall not be qualified to receive any payments for unemployment compensation while incarcerated, notwithstanding any other provision of the law to the contrary; and

(4) have participated in such employment voluntarily and have agreed in advance to the specific deductions made from gross wages pursuant to this section, and all other financial arrangements as a result of participation in such employment.

(d) This section shall not apply to goods, wares, or merchandise manufactured, produced, mined or assembled by convicts or prisoners who are participating in any pilot project approved by the FPI Board of Directors, which are currently, or would otherwise be, manufactured, produced, mined, or assembled outside the United States.

(e) For the purposes of this section, the term "State" means a State of the United States and any commonwealth, territory, or possession of the United States.

L. 98-473, title II, §609B(f), (o), Oct. 12, 1984, 98 Stat. 2093, 2096, provided that: “The provisions of section 1761 of title 18, United States Code, and of the first section of the Act of June 30, 1936 (49 Stat. 2036; [former] 41 U.S.C. 35 [see 41 U.S.C. 6502]), commonly known as the Walsh-Healey Act, creating exemptions to Federal restrictions on marketability of prison-made goods, as amended from time to time, shall not apply unless—

“(1) representatives of local union central bodies or similar labor union organizations have been consulted prior to the initiation of any project qualifying of any exemption created by this section; and

“(2) such paid inmate employment will not result in the displacement of employed workers, or be applied in skills, crafts, or trades in which there is a surplus of available gainful labor in the locality, or impair existing contracts for services.”

§ 1762. Marking packages

(a) All packages containing any goods, wares, or merchandise manufactured, produced, or mined wholly or in part by convicts or prisoners, except convicts or prisoners on parole or probation, or in any penal or reformatory institution, when shipped or transported in interstate or foreign commerce shall be plainly and clearly marked, so that the name and address of the

shipper, the name and address of the consignee, the nature of the contents, and the name and location of the penal or reformatory institution where produced wholly or in part may be readily ascertained on an inspection of the outside of such package.

(b) Whoever violates this section shall be fined under this title, and any goods, wares, or merchandise transported in violation of this section or section 1761 of this title shall be forfeited to the United States, and may be seized and condemned by like proceedings as those provided by law for the seizure and forfeiture of property imported into the United States contrary to law.

§ 1791. Providing or possessing contraband in prison

(a) OFFENSE.—Whoever—

(1) in violation of a statute or a rule or order issued under a statute, provides to an inmate of a prison a prohibited object, or attempts to do so; or

(2) being an inmate of a prison, makes, possesses, or obtains, or attempts to make or obtain, a prohibited object;
